remanded the case for further determination as to elements of the taking claim. On remand, the Circuit Court found a taking; however, on appeal, the 4<sup>th</sup> District Court of Appeal reversed the trial court's order finding a temporary taking and remanded the case for entry of a final judgment in favor of the Town.

Successful Representation of Landowner Against Water Control District

Representation of large landowner in dispute against water control district concerning the existence of an easement over client's property for recreation trails and canal maintenance. Municipality Prevailed in Adult Entertainment Business Closure

Successful representation of the Village of North Palm Beach in a two-count complaint seeking injunctive and declaratory relief prohibiting the operation of an adult entertainment business. A counterclaim was filed seeking a declaratory judgment declaring the Village's adult entertainment regulation unconstitutional. The trial court held that reasonable avenues for communication for adult entertainment were available under the Village' regulations. The court entered a Final Judgment upholding the constitutionality of the Village's regulations and requiring the business to immediately cease operation as an adult dancing business within the Village. The Fourth District Court of Appeal affirmed the trial court's Final Judgment.

# Municipality Prevails in Zoning Challenge

The County prevailed at trial and on appeal to the Fourth District Court of Appeal.

resident's construction of a boat canopy was a major amendment to the Planned Unit Development which included a marina. The Town Council initially disagreed with the Director's decision, which meant that a building permit had to be issued for construction of the boat canopy. Upon being presented with further information, the Council elected to conduct a rehearing. Before a date for the rehearing was set, and a Final Order was entered by the Council, the property owner filed suit alleging in his Writ of Prohibition that the Town was prohibited from reconsidering its decision. The Trial Court determined the Council had the authority to rehear the appeal and the Fourth District Court of Appeal affirmed.

# Veteran's Spouse Deemed Eligible for Government Benefits

Municipality Prevails in U.S. Court of Appeals in Case of First Impression Representation of the Town of Palm Beach in a matter of first impression in the area of land use and constitutional law. A longtime resident argued that the Town's architectural review commission violated his constitutionally protected First Amendment right to freedom of expression and his Fourteenth Amendment rights to due process and equal protection when in denied his application to demolish his traditional-style home and construct a new international/modern-style home on the oceanfront lot. The commission denied the application because the proposed mansion was "excessively dissimilar" from other nearby homes in accordance with various architectural design criteria. The federal appellate court held that although the resident may have intended to communicate a message through his proposed home, there was no great likelihood that a reasonable viewer would understand it to convey some sort of message where the residence was set back from the street and obscured by dense landscaping there was no evidence that residential architecture has been historically used or understood to convey a message. The court also rejected the resident's attempt to void the Town's architectural review ordinance. The resident petitioned the U.S. Supreme Court for review, but the court ultimately declined to hear the appeal in March 2022.

# Successful Defense of Class Certification Involving Underground Utility Project

Lead Counsel in the representation of a municipality in defense of putative class actions challenging the bond referendum and special assessment criteria involved in the Town of Palm Beach's \$90 million underground utility project. Trial court's order denying class certification after evidentiary hearing was affirmed on appeal.

# **Experience Highlights**

## Significant Recovery for Real Property Owner in Inverse Condemnation Lawsuit

Representation of a real property owner in an inverse condemnation lawsuit for the taking of submerged land by Palm Beach County without permission or compensation that resulted in reduced ability to develop the property. A seven-day jury trial resulted in an award of \$425,700 – a valuation approximately 27 times higher than the County's valuation of \$15,700.

# Successful Defense of Claim to Enforce Letter of Intent as a Binding Contract

Representation of seller in dispute with developer related to a previously executed letter of intent to convey a 93 acre parcel of land for \$10.5 million. The developer sought to enforce the letter of intent as a binding contract to sell the property after negotiations did not result in a final agreement. The state trial court granted final summary judgment in favor of the seller and the appellate court affirmed.

# Successful Defense of Developer's Claim for Specific Performance Regarding Purchase of Property

Representation of trust in dispute with developer who sought to specifically enforce the terms of a purchase and sale agreement of 8 acres of land for \$5 million against the trust. The developer also claimed that one trustee tortiously interfered with the agreement. The federal district court granted final summary judgment on all counts in favor of the trust and trustee shortly before trial. The developer appealed the summary judgment ruling to the 11th Circuit Court of Appeals. After oral argument, the appellate court affirmed the lower court ruling on all issues in a published opinion.
